



Procedure for the Submission of Comments regarding IFFO RS Fisheries, Factories, Standard and Process

This proceedure outlines the process through which stakeholders can submit comments about IFFO RS applicant or approved fisheries, applicant or certified factories, the IFFO RS Standard, and the IFFO RS process.

1.1 Who are Stakeholders?

Stakeholders include fishery participants (fishers), fish processors, fish traders, government fishery management organisations, non-government organisations and other parties or persons having information that may be important in the assessment of fisheries to the IFFO Responsible Supply (RS) Certification Program.

1.2 Stakeholder Input on fisheries and factories

The IFFO RS Assessment Process follows the requirements of ISO 17065 Accredited Certification and includes a comprehensive Stakeholder Engagement Procedure, as follows:

Fishery assessments are conducted remotely to ensure the raw material used by IFFO RS factories is responsibly sourced. Assessments, either full or surveillance, take place annually, and consider a range of aspects of fishery management as defined in the IFFO RS Standard. Factories are assessed via a site visit, which again occurs annually. A typical site visit includes a one-day inspection of the facilities and paperwork to ensure that all the requirements of the IFFO RS Standard are met.

Stakeholders may submit information relating to fisheries or factories at any time during the assessment process. Information is submitted to the relevant Certification Body and to the IFFO RS Sustainability Officer. The information will be reviewed by the certification body with respect to its eligibility and bearing on the conformance of an Applicant or existing approved fishery or certified factory. In the case of fisheries which have not previously been approved, or factories which have not been certified, submissions will be considered during the full initial assessment. In the case of approved fisheries or certified factories, submissions will generally be considered at the next surveillance assessment. An exception to this rule is that if information is deemed to be likely to render the fishery and/or factory no longer compliant with the IFFO RS Standard, the Certification Body may elect to open up an immediate investigation. For this reason, all information submitted by stakeholders should be reviewed by the Certification Body as rapidly as practicable.

1.4 Eligibility Criteria

Eligible submissions must meet the following requirements:

- Submissions must be non-confidential and available for reporting and referencing within the Assessment Process and Final Certification Reports.
- Submissions must contain the name and contact details of the Submitting Entity or Person and their relationship with the Fishery subject to the submission.
- Submission must be made via Official Comment Form on the website. Submitted material that is not accompanied with the Official Submission Form will not be eligible for assessment purposes.

1.5 Submission Form

Automated confirmation of receipt of submissions will be provided to the e-mail address.

1.6 Stakeholder Input on the IFFO RS Standard

IFFO RS Ltd allows for comments on the IFFO RS Standard and its procedures to be submitted by any interested party at any time and considers them during the subsequent Standards Revision Process by the Technical Advisory Committee (TAC). These comments may relate to the Standard itself, to the fishery or factory assessment processes, or to any other aspect of the IFFO RS programme.

IFFO also engages with the public during the Standards Review Phase and Standards Development Phase in the format of an Open Comment Period.

The Administration Assistant responsible for publicizing the commencement of a formal Open Comment Period in the national seafood media. This will state the Standard and the window for comment: e.g.

- Policies and Procedures guiding the Standard Setting Activity;
- Lists of Stakeholders contacted;
- Interested parties involved at each stage of the process;
- Comments received and a synopsis of how those comments were taken into account;

- All draft and final versions of the Standard.
